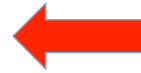

IF THERE IS A LEGAL LIMIT YOU MUST STAY WITHIN THE GUIDE LINES OF THE LAW

TOURNAMENT RULES - There aren't many rules, but we do have a few pointers:

1. BRING WEIGH SLIPS TO THE COOK OUT - **BUT ONLY SUBMIT ONE WEIGH SLIP PER PERSON**
2. MAJOR CATEGORIES INCLUDE FLUKE, SEABASS, BLUEFISH AND STRIPED BASS, BUT ALL SPECIES ELIGIBLE FOR A PRIZE
3. ONLY CATCHES WEIGHED ON A CERTIFIED SCALE AS PER MRMTC PROCEDURES COUNT TOWARD MAJOR CATEGORIES
4. IF THERE IS A LEGAL LIMIT YOU MUST STAY WITHIN THE GUIDE LINES OF THE LAW
5. **PLEASE MARK EACH WEIGH SLIP CLEARLY AS LADY OR JUNIOR**
6. EVERYONE GETS A PRIZE, BUT ONLY IF WE HAVE A WEIGH SLIP FOR THEM
 - If they don't catch anything, get creative "Biggest Seaweed", "Best Mate", etc...
BUT SUBMIT A WEIGH SLIP FOR SOMETHING FOR THEM
7. IF YOU WANT THE WEIGH SLIP TO BE CONSIDERED FOR A CATEGORY OR PRIZE OUTSIDE OF THIS TOURNAMENT, YOU MUST TAKE A PICTURE OR MAKE A COPY AND SUBMIT THAT WEIGH SLIP THRU THE NORMAL MRMTC PROCEDURE

The decision to fish or not relative to weather or any other reason is at the sole discretion of the participants. The entrant may elect to withdraw from the tournament if they are concerned with weather related sea conditions. All entry monies will be fully refunded as long as an officer, a trustee, or a tournament committee member is notified prior to the time of the captains meeting.

Participants must comply with all applicable governmental laws, rules and regulations. MRMTC assumes no responsibility in that or any other regard. Any non-complying fish will be disqualified.

I agree to the aforementioned terms and conditions, and represent that anyone invited to fish on the boat entered, has been informed and has accepted accordingly.
