

# WAR IN – SHORE INSHORE TOURNAMENT



**Date:** August 7<sup>th</sup> to August 13<sup>nd</sup>, 2022  
(Captain's Choice\* – Fish 1 day out of 7)

**Fishing Time:** boats may leave inlet at midnight and fish until 3:00PM day they are fishing

**Weigh In:** **CERTIFIED WEIGH IN SLIPS MUST BE SENT TO CLUB COMMITTEE PERSON BY 7 PM on DAY OF FISHING**

**Radio Channel:** VHF # 68 and 72

**\*\*\* 5- WAY CLUB V. CLUB TOURNAMENT\*\*\***

## **RULES**

1. There is no distance limit for this tournament, all boats must leave and return to their respective NEW JERSEY ports on their day of fishing.
2. Club Rules tournament (Non-IGFA)
3. Trolling/Jigging/Chunking/Live Bait is allowed.

4. All Entrants to be registered with Individual Club Tournament Committee Person by 8pm on Saturday (8/6). Boats are allowed to register for the tournament up until the final day, but optional calcuttas must be settled before declared fish day.
5. Disputes must be made to Club Committee Person by 8pm on day of fishing.
6. Disputes will be resolved by 5-person tournament committee by majority vote.
7. This will be a Club v. Club Tournament with NO ENTRY FEE.
8. Each competing boat will have the option to fish one day between August 7<sup>th</sup> and August 13<sup>th</sup>.
9. Entrants must declare their fishing day with their Club Tournament Committee person prior to their day of fishing
10. Each boat will have the option to enter 2 calcuttas:
  - a. Boat Entry - Overall heaviest flounder/2nd heaviest flounder(70/30 split), tied fish split place prize. (\$100)
  - b. Boat Entry – Overall heaviest stringer(3) flounder across all clubs (\$100)
11. 20% of total Calcutta entries for this event will be donated to a Charity for Childhood Leukemia Research in the Name of Parker Nork by each individual club.
12. Overall Club Winner will be determined by overall points (tiebreaker will be determined by time first fish caught
13. Overall Club Winner will have name engraved onto new INSHORE Trophy Award to be displayed at BHMTC with winning club's burgee above trophy for ENTIRE year.

## **POINTS/SCORING**

1. Points of TOP 5 BOATS OF CLUB totaled
  - a. Total points of top 5 boats participating from each club will be summarized for each individual club to create a "fair" playing field for all the clubs.
2. All Fish are scored 1 point per pound:
3. Boat bag limits/applicable fish are as follows:
  - a. Flounder – 3 fish per boat
  - b. Tog – 1 fish per boat
  - c. Weakfish – 1 fish per boat
  - d. Bluefish – 2 fish per boat
  - e. Sea Bass – 2 fish per boat
4. Certified weigh slips, or pictures of slips MUST be turned into club committee person by 7pm on the declared day of fishing.

## **OPTIONAL CALCUTTAS**

1. Boat Entry - Overall heaviest flounder/2nd heaviest flounder(70/30 split), tied fish split place prize. (\$100)
  - a. Gentleman's agreement between all clubs/entrants into the Calcutta for heaviest Single Summer Flounder

- b. In the event of a tie, the pot is split among tied entrants
  - c. If no flounder is caught, the entire pot amount will be donated to charity for Childhood Leukemia.
  - d. Boats are allowed to enter the Calcutta up until 8pm on the night PRIOR to their declared fishing day.
  - e. Boats entering the Calcutta must be paid in advance to the club tournament committee person.
2. Boat Entry – Overall Heaviest Stringer (3) Flounder across all clubs (\$100)
- a. Gentleman's agreement between all clubs/entrants into the Calcutta for heaviest Stringer (3) Summer Flounder
  - b. In the event of a tie, the pot is split among tied entrants.
  - c. If no flounder is caught, the entire pot amount will be donated to charity for Childhood Leukemia.
  - d. Boats are allowed to enter the Calcutta up until 8pm on the night PRIOR to their declared fishing day.
  - e. Boats entering the Calcutta must be paid in advance to the club tournament committee person.
